

William L. Sayre High School Parent and Family Engagement Policy

In support of strengthening student academic achievement, William L. Section A: JOINTLY DEVELOPED

William L. -The staff will maintain Contact Logs documenting their correspondence with families through the Google anecdotal record logs and the SIS communication logs. These logs will be updated daily and reviewed by leadership bi-monthly. -School Programs and Parent Volunteer sign-ins and logs will be maintained in the main office.

-The leadership learn will commue efforts of Farent Organizations, community partnerships and SAC learn. -Parent and family communication will be available on Main Office counter and available in various languages (all languages identified in school demographic).

-All communication from the school is sent to parents in easy-to-read language and in the languages spoken at home as requested. The Office of Family and Community Engagement is able to support the school in translating documents and telephone communication with non-English speaking parents upon request.

-Parent and Teacher Conferences will be held and a night conference will be scheduled to accommodate working families.

-Supporting the High School Student in Social, Emotional and Academic Success: November 2022.

-Focused Parent meetings around formative and summative assessments and how to assist students with testing: monthly beginning with test preparation 2022 between, 3:15pm-4:45pm and sometimes after 6pm per the parent enagagement survey.

-We will provide families training using Parent Portal (beginning in October) as a resource to support their connection to our school and their child's educational progress, as well as make certain during registration that parents are aware of Parent Portal and Student Portal and talk to their students as it relates to updates.

-Teachers will utilize SIS Gradebook, which will allow parents and students to log-on and keep abreast of their progress, as well as areas of strength and those with need for support and tutorials.

Section H: BUILDING CAPACITY OF SCHOOL STAFF

William L. Sayre High School will provide training to educate teachers, specialized instructional support personnel, principals, and other school leaders, and other staff, with the assistance of parents, in the value and utility of contributions of parents, and in how to reach out to, communicate with, and work with parents as equal partners, implement and coordinate parent programs, and build tics between parents and the school by:
